Cancellation Priorities:

NLBA Refund Policy:

All cancellations must be in writing and are subject to the following conditions:

- 25% Non-Refundable Cancellation Fee:** 25% of the registration fee on written cancellations received up to 15 working days prior to the start of each camp.
- 50% Non-Refundable Cancellation Fee:** 50% of the registration fee on written cancellations less than 15 working days prior to the start of each camp. NO SHOWS – NO REFUND!
- Any cancellations at any time prior to camp due to illness or injury will receive a 100% refund of registration fee. A medical certificate must accompany your written cancellation request.

For All PayPal transactions, PayPal takes off a fee. For anyone who has paid via PayPal and wants a refund / reimbursement, the NLBA will now deduct the PayPal amount from the amount given out.

NLBA reserves the right to request the withdrawal of any applicant prior to termination of the camp session, if in the opinion of the Director, coordinators, or the instructors, which the applicant camper has failed to, conduct him/herself in a reasonable manner.

NLBA reserves the right to cancel any camp session. In these circumstances, a full refund will be provided to registrants.
